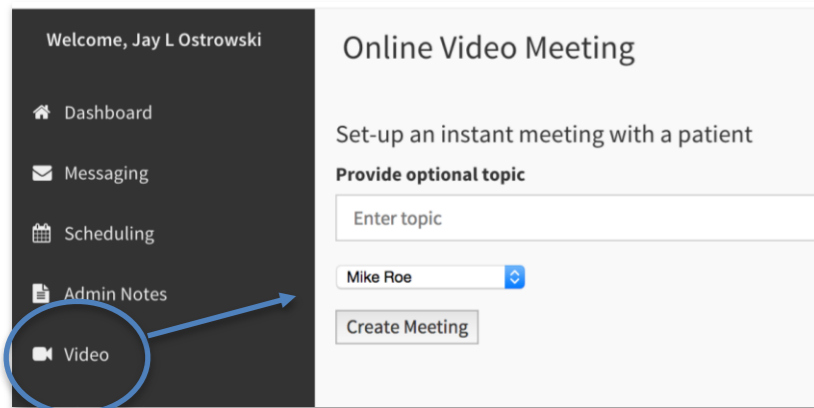

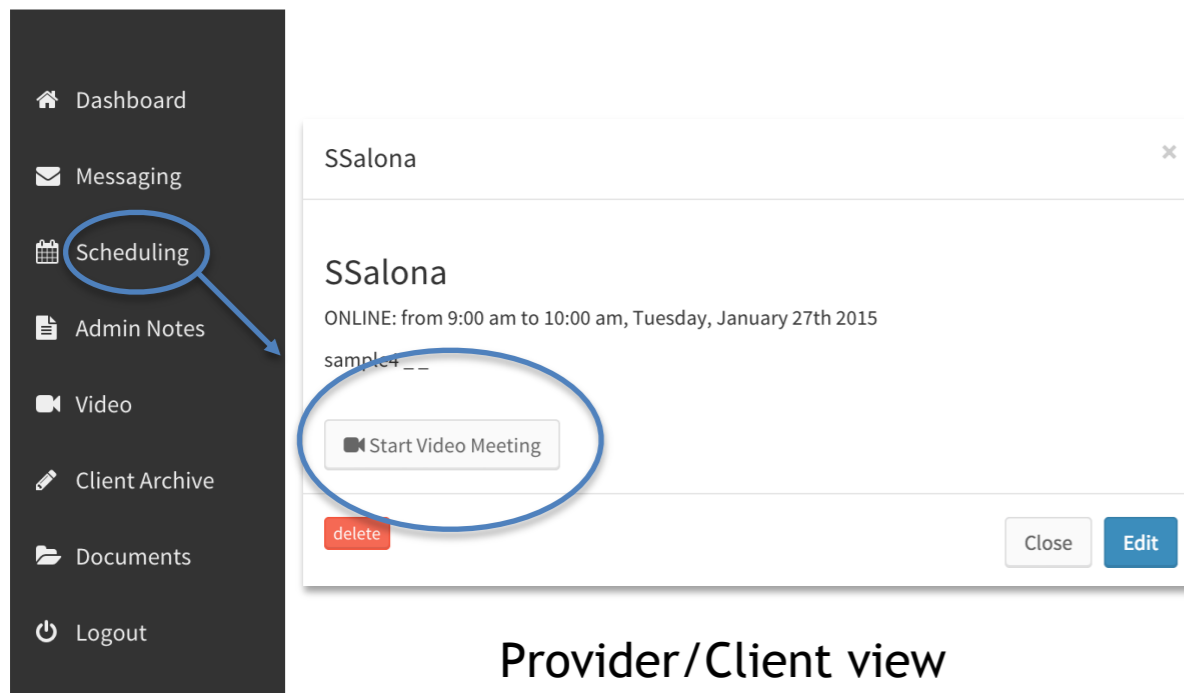
## 1. On-demand video

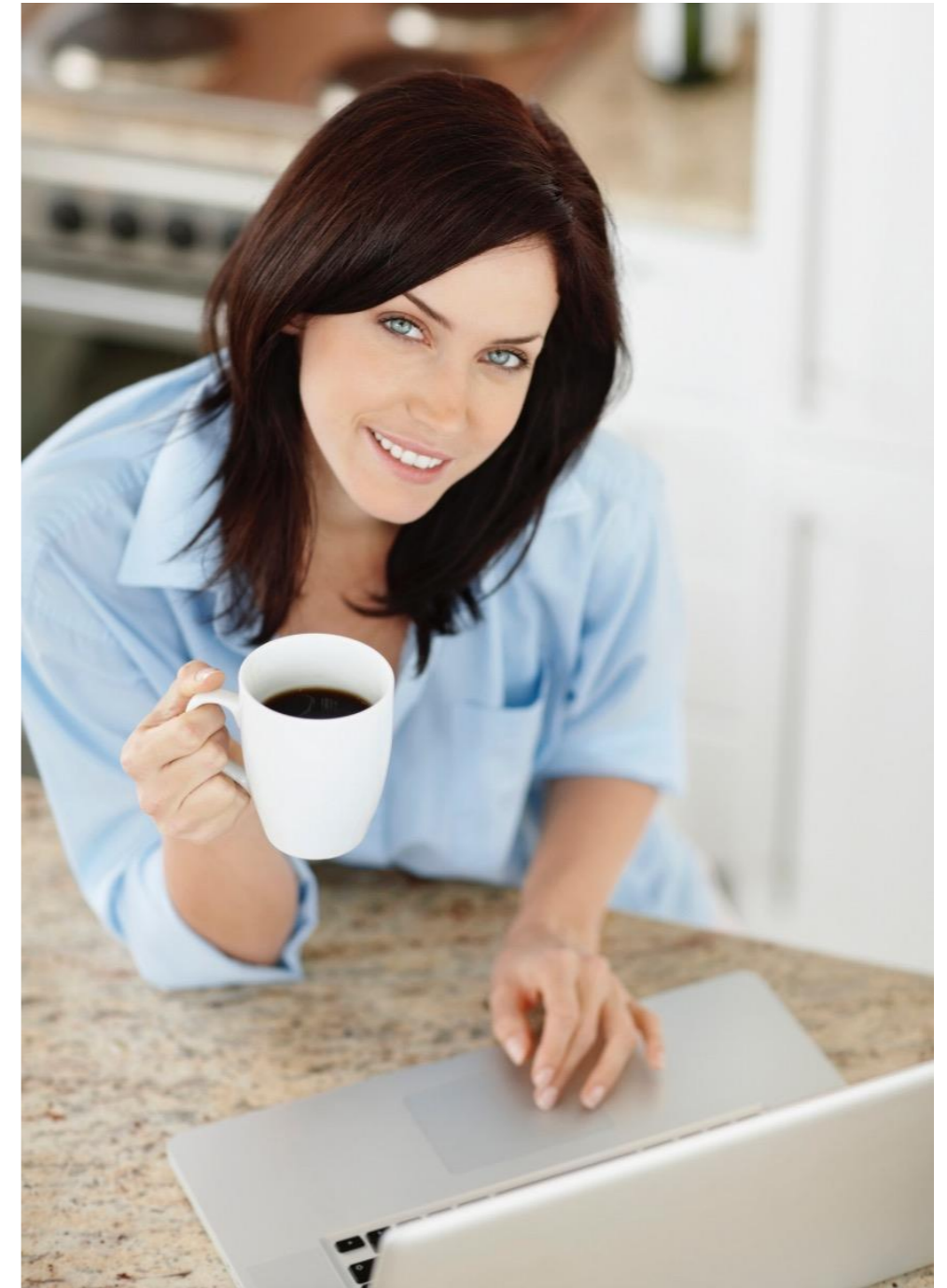
